

TOWN OF AZTALAN ANNUAL MEETING -APRIL 10TH, 2012

PLEDGE OF ALLEGIANCE

AT 6:05 P.M. ON APRIL 10TH, 2012 CHAIRPERSON OLSON CALLED THE ANNUAL MEETING OF THE AZTALAN TOWNSHIP TO ORDER. BOARD MEMBERS IN ATTENDANCE WERE CHAIRPERSON GENE OLSON, SUPERVISOR DAVE KUHL, SUPERVISOR JAMES FROHMADER, TREASURER STACY RIEDL AND CLERK SANDRA MARKS.
